The above executives are advised to report the CMO(I/C/HOD) of the respective Central Hospitals for further assignments.



The appointment is provisional and subject to verification of certificates from concerned Authorities & verification of all documents as per norms and in case at any subsequent stage of appointment, if it is detected that the certificates are not genuine, his services can be terminated based on the certification report of the concerned authorities.

The above-mentioned Sr. Medical Officers and Medical Specialist in E3 grade will be on probation for a period of one year which may be extended at the sole discretion of the Management depending on the performance of the executive. On successful completion of the probationary period of service he/she will be confirmed as regular employee.
