Sri Ashim Kumar Mahato, Sr. Officer (Min), presently posted at Satgram-Sripur Area is hereby transferred to Mugma Area.


Sri Vinay Kumar Singh, Sr. Officer (Min), presently posted at Sodepur Area is hereby transferred to Jhanjra Area.
