

**NOTICE FOR THE ISSUANCE OF REVISED PPO BY THE CMPFO TO THE EXISTING PENSIONERS FOR HASSLE-FREE PAYMENT OF PENSION TO THEIR SPOUSE (Reference No. CPF/111(26)/Pen/Misc./HQ/Vol-III/520 Dated 25/08/2023 of the Commissioner, CMPFO and letter no. CIL/CH/4354 dated 03.01.2024, issued by the Chairman, Coal India Limited)**

This is for information to all beneficiaries under CMPS 1998 who are availing pension.

As Notified by the CMPFO, for hassle-free payment of pension as per CMPS-98 to the spouse, Revised PPO will be issued to the Member pensioners. For the said Purpose, the Member Pensioners will have to submit the following documents along with an application (In the prescribed format):

1. Two copies of Application in the prescribed format.
2. Joint photographs with spouse (three copies).
3. Two copies of existing Bank Account details of the Pensioner (First page of passbook) in *Former or Survivor* mode of operation which should be operative with spouse (It is mandatory that the Bank account no. of the pensioners where from the pensioner is getting his pension should be converted in Former or Survivor mode (if not so).
4. Copy of Aadhaar and PAN card of pensioners and spouse (Two copies).
5. Old PPO Copy (Two copies).
6. All the aforesaid documents should **be attested** by the Member pensioner and Spouse.

**The applicant(s) are requested to send the aforementioned documents along with the duly filled in application to the office(s) of the concerned Colliery/Area/Estb. /HQ office(s) wherefrom the ex-employee has separated (on the ground of Superannuation/ VRS/ Resignation), for processing the same and to further forward to the concerned Regional CMPFO for issuance of revised PPO.**
